

Passes for members are \$11.25 each (discounted price) and can *only be* 

purchased online at www.maritimefun.com beginning on June 20, 2024.

Click on Maritime Fun Group **BUY PASSES** from their homepage and then click on **HAVE AN ACCESS CODE** to activate the discount. Then continue to checkout as normal.



If your code is used to purchase more

than **4** passes, **all passes will be rendered null and void.** 

- children under **thirty-six** inches will not require a pass.
- UPSE ID will be required to show at the gate
- passes **cannot be purchased at the Union** they must be purchased online at **www.maritimefun.com**

**beginning** on **June 20**. When purchasing your passes you must select a date **July 14 or 21** and use your **CODE** to get the discount.

- only UPSE members can purchase passes at the discount rate. **There are up to 4 passes available per** 

household. If additional passes are needed, you must complete a new transaction at regular prices.

- members are **on their own** for food purchases at Shining Waters or Sandspit.

### **Information about JOSH Committees**

**What is a JOSH Committee?** A Joint Occupational Safety and Health (**JOSH**) Committee is a group of worker and employer representatives who work together to address health and safety issues in their work-

place.

**Do you need a JOSH Committee?** If your workplace employs twenty or more workers, the law on Prince Edward Island says that a Joint Occupational Health and Safety Committee (committee) must be established.

Who is on the JOSH Committee? The committee is composed of an equal number of worker and employer representatives who provide a link between management and staff, so that health and safety solutions can be developed, together under the internal responsibility system.
